We received a quote for some new kitchen appliances in the amount of \$5,108.66 however the quote included a 48' grill and the one needed will be smaller so the price should be less. Vicki will get the updated quote with the correct size grill. The outside walk-in cooler has been repaired as well as the AC unit for the porch. We received notice and price from Waldvogel sealcoating as a reminder to reseal the parking lot. We will continue to monitor the need and determine a course of action.
