- C. <u>Finance report</u> Chuck As of this meeting we have \$156,012.02 in the checkbook with approximately \$4000 in outstanding bills. We received the Financial Statements and Accountant's Report from Tina Flanery of Northern Financial Services for 2024 which was delayed from the annual meeting in June. Chuck briefly went over some of the figures. The financial statement can be seen at Vicki's office in the clubhouse. October net income was (\$27,957) down from (\$3,239) last year. Expenses were \$89,326 up from \$67,282 last year. Year to Date figures are as follows:

D. <u>Grounds report</u> - Rob - We are still working on the pump issues and waiting for contact with the repair company. It is the same company that blows the watering system out for the winter so contact will be made soon. He has been busy with leaf removal and the weather has been cooperating much better this year. He received the small mower for the leaf blower/vacuum and it is working good. Rob will be compiling a list of future needed equipment and bring it to the November meeting. We can then make a financial plan for next season. Motion to accept the grounds report by Jesse, 2nd by Ken. Motion carried.

Manager report - Vicki - The 1st Annual Eric Swanson Memorial tournament and fundraiser was a great success with 175 golfers attending. The course received almost \$9000 for the event. Penny and Chris will be cleaning the kitchen and shutting it down for the season. We will be selling 3 carts this year and replacing them in the spring to continue the rotation of our fleet. There are a few winter projects Vicki mentioned including: new front door closer and latch, repairs on an electrical issue in the basement, placing a key drop-box outside the office for late cart users and updating the basement locker room area. We need to address the 2026 stockholder fee schedule & membership enrollment form. Vicki will contact our reciprocal courses and see if the fees are comparable.
