C. <u>Finance report</u> - Chuck - The August 31 balance of the 2024 note at Laona State Bank is a bit under \$150,000.00 and the original note is approximately \$9,600.00 in which our payments of \$1,700/mo. are mostly principle. Chuck spoke with Tina Flanery in regards to our missing annual report from the accountant. She apologized for the delay and will be working on this personally. We will receive the report when it is completed. There is approximately \$170,000.00 in the check book and we haven't received monies from two tournaments yet. August net income was \$64,214 up from \$32,631 last year. Expenses were \$62,108 down from \$96,165 last year. Year to Date figures are as follows:

Manager report - Vicki - The club tournament had 33 golfers with Reid Votis recording a 38, 33, & 32 for a 103 and the title of 2025 Club Champion. See our facebook page for all the other flight winners. The annual fundraiser outing had 90 golfers with a total of \$6,755.55 raised. We had 62 student memberships this year, up from 33 last year, a good sign for future golfers. We will be losing a couple employees for next season. Chris, one of our cooks, will be moving on and Cheryl will not be returning. There are two stock transfers this month, Curt & Maria Reitz to Tim Chrisman and Tom & Angie Bal to Autumn Albrecht. features, we will not be burdened by outages and customers will be able to reach us even in the event of downed lines. Scott reports that we have repaired the seats on 8 or more carts this season. There are only a few left to finish.
